San Diego Port Commission Board Members:

If the Board is committed to doing it's "fiduciary duty to the integrity of the port and its commitments, and the well-being of port employees" (quote by Sonia Carvalho, attorney with Best Best & Krieger), then clear evidence needs to be presented showing what Commissioner Naranjo supposedly did was cause for censor. If not, then the public questions the actions of the Port and believes there is a cover-up of illicit activities by the Port's employees.

The selective investigation of the issues that were considered by the Port, and the wrong interpretation of Commissioner Naranjo's action violating the Brown Action, indicates a clear bias. And the lack of public disclosure is a prime example of the Grand Jury findings that the Port lacks transparency.

Commissioner Naranjo's leadership, dedication and commitment to her community, makes her the

ideal candidate for the position of Chair. By voting in favor of Commissioner Naranjo, the Port Commission will uphold its Board Policy 001 of fair rotation between South Bay and San Diego representation, but also ensures that National City residents receive due representation and the opportunity to actively contribute to the Port's achievements.

Further, the unjust censure placed upon Commissioner Naranjo should promptly be rescinded.
