

**AMENDMENT NO. 4 TO AGREEMENT BETWEEN  
SAN DIEGO UNIFIED PORT DISTRICT  
and  
COCHRAN MARINE, LLC  
for  
B STREET AND BROADWAY PIER SHORE POWER  
SYSTEM SUPPORT SERVICES  
AGREEMENT NO. 113-2016SN**

The parties to this Amendment No. 4 to Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a Public Corporation (District) and COCHRAN MARINE, LLC, a Washington Limited Liability Company (Service Provider).

Recitals:

District and Service Provider are parties to an Agreement for B Street and Broadway Pier Shore Power System Support Services. The agreement is on file in the Office of the District Clerk as Document No. 65443 dated August 9, 2016, as amended by Amendment No. 1, Document No. 67564 dated December 7, 2017, as amended by Amendment No. 2, Document No. 68844 dated August 28, 2018, as amended by Amendment No. 3, Document No. 69200 dated December 21, 2018. It is now proposed to extend the agreement from June 30, 2019, to September 30, 2019, to increase the agreement by \$25,843.58 from a total of \$735,000 to \$760,843.58, and to amend Attachment A, Scope of Services and Attachment B, Compensation & Invoicing.

The Parties Agree:

1. Section 2. **TERM OF AGREEMENT**, is hereby extended and shall terminate on September 30, 2019.
  
2. Section 3.a. **Maximum Expenditure**, is hereby amended to increase the agreement amount by \$25,843.58 from a total of \$735,000 to a new, not to exceed, total amount of \$760,843.58.

3. **Attachment A, Scope of Services**, Section 1. Shall be amended to include the following:

v. Testing and Commissioning (July 2019-September 2019)

1. Office Support
2. Automation and System Programming
3. Automation Services
4. Shore Power System Set Up

4. **Attachment B, Compensation & Invoicing**, Section 1. a. (2), Fee Table shall be deleted in its entirety and replaced with the following:



## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, San Diego Unified Port District (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**
