

**AMENDMENT NO. 3 TO AGREEMENT BETWEEN

ENVIRONMENTAL REVIEW CONSULTING SERVICES FOR THE TENTH AVENUE
MARINE TERMINAL MARITIME BUSINESS PLAN UPDATE PROJECT
AGREEMENT NO. 81-2013**

The parties to this Amendment No. 3 to Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation (District) and ICF JONES & STOKES, INC., a Delaware Corporation (Service Provider).

Recitals:

District and Service Provider are parties to an Agreement for Environmental Review Consulting Services for the Tenth Avenue Marine Terminal Business Plan Update Project. The agreement is on file in the Office of the District Clerk as Document No. 61425 dated March 24, 2014, as amended by Amendment No. 1, Document No. 64564 dated March 3, 2016, and Amendment No. 2, Document No. 65613 dated September 19, 2016. It is now proposed to increase the agreement amount by \$30,000 from a total of \$584,980.00 to \$614,980.

The Parties Agree:

1. Section 3.a, MAXIMUM EXPENDITURE, is hereby increased from \$584,980.00 by \$30,000 to a new total not to exceed \$614,980.

2. Attachment A, **SCOPE OF SERVICES**, is hereby amended to add the following:

Additional effort required for the preparation of the Final EIR, which will include a new project alternative referred to as the Sustainable Terminal Capacity Alternative. Subsequent technical analyses related to air quality, health risk assessment, and greenhouse gas modeling are advised to determine impacts associated with the Sustainable Terminal Capacity Alternative. (\$11,080 for Task 3 Technical Studies + \$12,970 for Task 5 Final EIR + \$5,950 for Task 7 Meetings, Hearings, Project Management, and Quality Control).


3. All other terms, covenants, and conditions in the original Agreement shall remain in full force and effect and shall be applicable to this Amendment.
