RESOLUTION APPROVING PLANS AND SPECIFICATIONS AND AWARDING CONTRACT NO. 2019-14 TO BAKER ELECTRIC, INC. IN THE AMOUNT OF \$268,000 FOR THE COLD IRONING (SHORE POWER) PHASE II AT B STREET AND BROADWAY PIERS PROJECT, SAN DIEGO, CALIFORNIA AS AUTHORIZED BY THE BOARD IN THE FY 2019-2023 CAPITAL IMPROVEMENT PROGRAM

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix 1, (Port Act); and

WHEREAS, Section 37 of the Port Act requires that the California Public Contract Code (PCC) apply to public projects of the District; and

WHEREAS, the Board of Port Commissioners (BPC) adopted the Uniform Public Construction Cost Accounting Act (Accounting Act) procedures of the PCC to apply to public projects of the District via BPC Resolution 98-249; and

WHEREAS, the BPC adopted BPC Policy 110 incorporating the provisions of the Accounting Act to govern the processing and administration of public projects; and

WHEREAS, staff recommends the Board approve the plans and specifications and award Contract No. 2019-14 to Baker Electric, Inc. in the amount of \$268,000 for the construction of the Cold Ironing (Shore Power) Phase II at B Street and Broadway Piers Project; and

WHEREAS, the plans and specifications define the contract work including installation of the previously purchased cold ironing phase 2 medium voltage electrical equipment, and removal, replacement, and termination of medium voltage cables; and

WHEREAS, the installation of the previously purchased cold ironing phase 2 medium voltage electrical equipment, and removal, replacement, and termination of medium voltage cables is necessary to double the capacity of the existing shore power system to comply with the updated California Air Resources Board (CARB) At-Berth Regulation to reduce air emission from ships while docked at berth; and

WHEREAS, CARB's At-Berth Regulation has become more stringent and starting on January 1, 2023, with a few exceptions, all cruise ships calling in San Diego will need to connect to shore power; and

WHEREAS, this contract is the third contract of four (4) major agreements necessary to complete the project of installing phase 2 shore power infrastructure to double the capacity of its existing shore power system by January 1, 2023; and

WHEREAS, the project's construction plans, and specifications were advertised on November 18, 2021; and

WHEREAS, bids were opened on December 8, 2021 and a total of three (3) construction bids were received ranging from \$268,000 to \$488,000; and

WHEREAS, the lowest responsive and responsible bid was received from Baker Electric, Inc., in the amount of \$268,000; and

WHEREAS, staff recommends that the BPC approve the plans and specifications and award Contract No. 2019-14, for the Cold Ironing (Shore Power) Phase II at B Street and Broadway Piers Project, San Diego, California, to Baker Electric, Inc. in the amount of \$268,000; and

WHEREAS, this project is included in the FY 2019-2023 Capital Improvement Program (CIP) with a project budget of \$600,000; approval of this agenda will authorize the construction contract expenditure of \$268,000 from the CIP funding appropriation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Port Commissioners of the San Diego Unified Port District, as follows:

That the Plans and Specifications for Contract No. 2019-14, are hereby approved and Contract No. 2019-14, for the construction of the Cold Ironing (Shore Power) Phase II at B Street and Broadway Piers Project, San Diego, California, in the amount of \$268,000 is hereby awarded to Baker Electric, Inc.
