<p>PASSENGER FEES</p> <p>Every vessel carrying passengers for compensation shall be liable for and pay the following fees for the use of wharves or wharf premises, passenger terminals, gangways, passenger loading bridges, anchorage and associated facilities.</p> <p>CRUISE SHIPS:</p> <p>(a) Passengers, embarking or disembarking to or from passenger vessels, through Port of San Diego facilities, or passengers in-transit on passenger vessels at Port of San Diego facilities, per passenger:</p> <p>OTHER VESSELS, PASSENGERS FOR HIRE:</p> <p>(b) Passengers, embarking or disembarking to or from day cruises only, through Port of San Diego facilities, per passenger (See NOTE 2):</p> <p>(c) Passengers, embarking or disembarking to or from inter-city coastal ferries, through Port of San Diego facilities, per passenger (See NOTE 2):</p> <p>(d) Passengers embarking or disembarking to or from vessels carrying passengers for hire, through Port of San Diego facilities (See NOTE 2):</p> <p>PASSENGER FEES DO NOT APPLY TO:</p> <p>EXCEPTION 1: Passengers on vessels entirely engaged in the carriage of passengers for promotion (not for compensation).</p> <p>EXCEPTION 2: Steamship company officials, only, when traveling aboard their own ships.</p> <p>NOTE 1: The owner, agent, master of other person in charge of a passenger carrying vessel, subject to the fees in this Item, shall furnish to the Executive Director complete copies of the vessel's passenger manifest listing the number of passengers embarking, disembarking, or in transit at the Port of San Diego.</p> <p>NOTE 2: Percentage rents may apply as defined in Item No. 0527.</p>	<p>\$10.00</p> <p>\$3.12</p> <p>\$1.54</p> <p>\$7.46</p>	<p>0647</p>
<p>CRUISE FACILITY IMPROVEMENT FEE—CRUISE SHIPS</p> <p>In addition to the Passenger Fees in Item No. 0647, every cruise ship carrying passengers for compensation shall further be liable for and pay a Cruise Facility Improvement Fee (CFI Fee) per embarking passenger, per disembarking passenger, and per in-transit passenger for the use of wharves or wharf premises, passenger terminals, gangways, passenger loading bridges, anchorages, and associated facilities.</p> <p>EXCEPTIONS 1 and 2 and NOTE 1 in Item No. 0647 apply to this Item No. 0648 as if set forth fully herein.</p>	<p>\$5.50</p>	<p>0648 (A)</p>
