RESOLUTION AUTHORIZING AN 8-YEAR MUNICIPAL SERVICES AGREEMENT WITH THE CITY OF CORONADO FOR LAW ENFORCEMENT, FIRE, LIFEGUARD AND EMERGENCY SERVICES ON NON-AD-VALOREM DISTRICT PROPERTY LOCATED IN THE CITY OF CORONADO

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the legislature in 1962 pursuant to Harbors and Navigation Code Appendix 1, (Port Act); and

WHEREAS, Section 21 of the Port Act authorizes the Board of Port Commissioners (Board) to pass all necessary ordinances and resolutions for the regulation of the District; and

WHEREAS, the District reimburses each of its five member cities for certain law enforcement, firefighting, lifeguard, and emergency medical services provided on non-ad-valorem taxpaying District tidelands within the geographical boundaries of each city; and

WHEREAS, the agreements through which the member cities are reimbursed for these services are referred to as Municipal Services Agreements (MSAs); and

WHEREAS, on June 15, 2021, the Board authorized a one-year extension to Coronado's previously effective long-term MSA from July 1, 2021 to June 30, 2022, along with a three percent (3%) increase to the prior baseline rate for services; and

WHEREAS, staff subsequently executed an administrative, short-term MSA expiring on August 19, 2022 with Coronado to allow additional time to finalize negotiations on a new, long-term MSA; and

WHEREAS, staff has negotiated a new, eight-year MSA with Coronado in the form attached to the agenda to which this Resolution relates that includes substantially the same language as the MSAs with the other four member cities; and

WHEREAS, under the terms of its new MSA, Coronado has agreed to a new yearly baseline rate of approximately \$1.33 million for police, fire, lifeguard, and emergency medical services to be provided on non-tax paying tidelands, an increase of 12% compared to the fiscal year (FY) 2022 rate; and

WHEREAS, commencing July 1, 2023, the baseline rate under Coronado's new MSA is subject to 4% annual increases; and

WHEREAS, the baseline rate under Coronado's new MSA is additionally subject to adjustment and renegotiation on baseline reset dates of July 1, 2025 and July 1, 2028; and

WHEREAS, the new baseline rate was calculated using the ratio of calls for service for law enforcement, firefighting, certain emergency response services and lifeguard services on non-tax paying tidelands to the total calls for service in the City of Coronado and applying that to the overall budgets for the respective service departments, including an average annual expense for vehicle replacement and capital expenditures, plus a 10% overhead/administrative fee for each of the service categories; and

WHEREAS, staff believes that this methodology and calculation represents a fair and justifiable reimbursement to the City of Coronado for services provided on non-tax paying tidelands; and

WHEREAS, in light of the foregoing, staff recommends the Board authorize an 8-Year Municipal Services Agreement with the City of Coronado for law enforcement, fire, lifeguard and emergency services on non-ad-valorem District property located in the City of Coronado.

NOW, THEREFORE, BE IT RESOLVED by the Board of Port Commissioners of the San Diego Unified Port District that the Executive Director, or his designee, is hereby authorized on behalf of the San Diego Unified Port District to enter into an 8-Year Municipal Services Agreement with the City of Coronado in the form attached to the agenda to which this Resolution relates for law enforcement, fire, lifeguard and emergency services on non-ad-valorem District property located in the City of Coronado.
