The terms of the recipient¿s approved Investment Justification(s) and Budget Detail Worksheet(s) submitted by the recipient are incorporated into the terms of this Federal award, subject to the additional description and limitations stated in this Agreement Article and the limitations stated in subsequent reviews by FEMA of the award¿s budget.

Project 1: Port of San Diego Resilience and Readiness Program is fully funded for \$131,228.

Project 2: Port District Homeland Security Strategic Plan is fully funded for \$76,500.

Project 3: B Street Cruise Ship Terminal - Security Gate Physical Enhancements is partially funded for \$96,030. Contigency Costs are not allowable.

Project 4: Tenth Avenue Marine Terminal (TAMT) - Security Gate Physical Enhancements is partially funded for \$347,985. Contigency Costs are not allowable.

Article II - DHS Specific Acknowledgements and Assurances

All recipients, subrecipients, successors, transferees, and assignees must acknowledge and agree to comply with applicable provisions governing DHS access to records, accounts, documents, information, facilities, and staff.
