

**AMENDMENT NO. 3 TO AGREEMENT BETWEEN

The parties to this Amendment No. 3 to Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation (District or Sponsor) and The Regents of the University of California (University).

**Recitals:**

District and Service Provider are parties to an Agreement for Sea Grant Fellowship. The agreement is on file in the Office of the District Clerk as Document No. 66057 dated January 19, 2017, as amended by Amendment No. 1, Document No. 67704 dated January 22, 2018 and as amended by Amendment No. 2, Document No. 69298 dated January 22, 2019. It is now proposed to extend the Agreement from March 31, 2020 to March 31, 2021, to increase the agreement amount by \$170,956.00 from a total of \$452,797.53 to \$623,753.53 and to add Exhibit B-2.

**The Parties Agree:**

1. The Paragraph entitled **SCHEDULE**, is hereby extended and shall terminate on March 31, 2021.
2. The paragraph entitled **BUDGET**, is hereby increased from \$452,797.53 to \$623,753.53.
3. **EXHIBIT B-2**, 2020 Budget Detail, attached hereto, shall be added to Exhibit B.

4. All other terms, covenants, and conditions in the original Agreement shall remain in full force and effect and shall be applicable to this Amendment.
