AGREEMENT BETWEEN SAN DIEGO UNIFIED PORT DISTRICT and WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC. for AS NEEDED ENVIRONMENTAL ANALYTICAL SERVICES AGREEMENT NO. 06-2020JR

The parties to this Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation (District) and WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC., a NEVADA CORPORATION (Service Provider). The parties agree to the following:

1. <u>SCOPE OF SERVICES</u>. Service Provider shall provide services to satisfactorily comply with Attachment A, Scope of Services, attached hereto and incorporated herein, as requested by District. Service Provider shall keep the Executive Director of the District or their designated representative informed of the progress of said services at all times.

a. As-Needed Services

- (1) Service Provider is aware that the services to be provided under this Agreement are on an as-needed basis as determined by the District. Service Provider may or may not receive a request to provide such services, and Service Provider may not receive the maximum expenditure of funds allocated for these services. No work or services will be performed until a Task Authorization (TA) has been signed by the District Representative.
- (2) Service Provider shall furnish all technical and professional labor, and materials to satisfactorily comply with Attachment A: Scope of Services as requested by District by issuance of specific Task Authorization and agreed to by Service Provider.
- (3) Services rendered under this Agreement shall be undertaken by Service Provider only upon issuance of a Task Authorization (TA) for said services, in the format as shown in the attached Exhibit A, attached hereto and incorporated herein. A Task Authorization shall

not be considered effective until the Task Authorization has been signed by the District's designated representative.

- 2. <u>**TERM OF AGREEMENT**</u>. This Agreement shall commence on March 1, 2020 and shall terminate on July 31, 2023, subject to earlier termination as provided below.
- 3. <u>COMPENSATION</u>. For performance of services rendered pursuant to this Agreement and as further described in Attachment B, Compensation and Invoicing, attached hereto and incorporated herein; District shall compensate Service Provider based on the following, subject to the limitation of the maximum expenditure provided herein:
 - a. <u>Maximum Expenditure</u>. The aggregate amount under this Agreement with Service Provider and Agreements with companies listed in Table 1, parties to Aggregate Agreements, below, shall not exceed \$1,500,000.00.

Said expenditure shall include without limitation all sums, charges, reimbursements, costs and expenses provided for herein. Service Provider shall not be required to perform further services after compensation has been expended. In the event that the Service Provider anticipates the need for services in excess of the maximum Agreement amount, the District shall be notified in writing immediately. District must approve an amendment to this Agreement before additional fees and costs are incurred.

- b. <u>Payment Procedure</u>. For work performed on an hourly basis, Service Provider agrees to assign the person with the lowest hourly rate who is fully competent to provide the services required. If Service Provider finds it necessary to have work, which would usually be performed by personnel with a lower rate, performed by personnel paid at the higher hourly rate, Service Provider shall nevertheless, bill at the lower rate.
- c. <u>Progress Documentation</u>. Service Provider shall provide District progress reports in a format and on a schedule as District directs. Progress reports shall include a description of work completed, cumulative dollar costs incurred, anticipated work for the next reporting period, percentage of work complete, and the expected completion date for remaining work. The report shall identify problem areas and important issues that may affect project cost and/or schedule. The report shall present actual percent completion versus planned percent completion.

4. <u>RECORDS</u>

- a. Service Provider shall maintain full and complete records of the cost of services performed under this Agreement. Such records shall be open to inspection of District at all reasonable times in the City of San Diego and such records shall be kept for at least three (3) years after the termination of this Agreement.
- b. Such records shall be maintained by Service Provider for a period of three
 (3) years after completion of services to be performed under this Agreement or until all disputes, appeals, litigation or claims arising from this Agreement have been resolved, whichever is later.
- c. Service Provider understands and agrees that District, at all times under this Agreement, has the right to review project documents and work in progress and to audit financial records, whether or not final, which Service Provider or anyone else associated with the work has prepared or which relate to the work which Service Provider is performing for District pursuant

to this Agreement regardless of whether such records have previously been provided to District. Service Provider shall provide District at Service Provider's expense a copy of all such records within five (5) working days of a written request by District. District's right shall also include inspection at reasonable times of the Service Provider's office or facilities, which are engaged in the performance of services pursuant to this Agreement. Service Provider shall, at no cost to District furnish reasonable facilities and assistance for such review and audit. Service Provider's failure to provide the records within the time requested shall preclude Service Provider from receiving any compensation due under this Agreement until such documents are provided.

5. SERVICE PROVIDER'S SUB-SERVICE PROVIDERS

- a. It may be necessary for Service Provider to sub-contract for the performance of certain technical services or other services for Service Provider to perform and complete the required services; provided, however, all Service Provider's Sub-Service Providers shall be subject to prior written approval by District. The Service Provider shall remain responsible to District for any and all services and obligations required under this Agreement, whether performed by Service Provider or Service Provider's Sub-Service Providers. Service Provider shall compensate each Service Provider's Sub-Service Providers in the time periods required by law. Any Service Provider's Sub-Service Providers and not agents of District. Service Provider shall be independent Service Provider's Sub-Service Provider's Sub-Service Providers and not agents of District. c. Service Provider shall also include a clause in its Agreements with Service Provider's Sub-Service Providers which reserves the right, during the performance of this Agreement and for a period of three (3) years following termination of this Agreement, for a District representative to audit any cost, compensation or settlement resulting from any items set forth in this Agreement. This clause shall also require Service Provider's Sub-Service Providers to retain all necessary records for a period of three (3) years after completion of services to be performed under this Agreement or until all disputes, appeals, litigation or claims arising from this Agreement have been resolved, whichever is later.

6. <u>COMPLIANCE</u>

- a. In performance of this Agreement, Service Provider and Service Provider's Sub-Service Providers shall comply with the California Fair Employment and Housing Act, the American with Disabilities Act, and all other applicable federal, state, and local laws prohibiting discrimination, including without limitation, laws prohibiting discrimination because of age, ancestry, color, creed, denial of family and medical care leave, disability, marital status, medical condition, national origin, race, religion, sex, or sexual orientation. Service Provider shall comply with the prevailing wage provisions of the Labor Code, and the Political Reform Act provisions of the Government Code, as applicable.
- b. Service Provider shall comply with all Federal, State, regional and local laws, and district Ordinances and Regulations applicable to the performance of services under this Agreement as exist now or as may be added or amended.
- 7. INDEPENDENT ANALYSIS. Service Provider shall provide the services required by this Agreement and arrive at conclusions with respect to the rendition of information, advice or recommendations, independent of the control and direction of District, other than normal contract monitoring provided, however, Service Provider shall possess no authority with respect to any District decision.
- 8. <u>ASSIGNMENT</u>. This is a personal services Agreement between the parties and Service Provider shall not assign or transfer voluntarily or involuntarily any of its rights, duties, or obligations under this Agreement without the express written consent of District in each instance.

9. INDEMNIFY, DEFEND, HOLD HARMLESS

a. <u>Duty to Indemnify, duty to defend and hold harmless</u>. To the fullest extent provided by law, Service Provider agrees to defend, indemnify and hold harmless the District, its agents, officers or employees, from and against any claim, demand, action, proceeding, suit, liability, damage, cost (including reasonable attorneys' fees) or expense for, including but not limited to, damage to property, the loss or use thereof, or injury or death to any person, including Service Provider's officers, agents, subcontractors, employees, ("Claim"), caused by, arising out of, or related to the performance of services by Service Provider as provided for in this Agreement, or failure to act by Service Provider, its officers, agents, subcontractors and employees. The Service Provider's duty to defend, indemnify, and hold harmless shall not include any Claim arising from the active negligence, sole negligence or willful misconduct of the District, its agents, officers, or employees.

- b. The Service Provider further agrees that the duty to indemnify, and the duty to defend the District as set forth in 9.a, requires that Service Provider pay all reasonable attorneys' fees and costs District incurs associated with or related to enforcing the indemnification provisions, and defending any Claim arising from the services of the Service Provider provided for in this Agreement.
- c. The District may, at its own election, conduct its defense, or participate in the defense of any Claim related in any way to this Agreement. If the District chooses at its own election to conduct its own defense, participate in its own defense or obtain independent legal counsel in defense of any Claim arising from the services of Service Provider provided for in this Agreement, Service Provider agrees to pay all reasonable attorneys' fees and all costs incurred by District.

10. INSURANCE REQUIREMENTS

a. Service Provider shall at all times during the term of this Agreement maintain, at its expense, the following minimum levels and types of insurance:

- (1) Commercial General Liability (including, without limitation, Contractual Liability, Personal Injury, Advertising Injury, and Products/Completed Operations) coverages, with coverage at least as broad as Insurance Services Office Commercial General Liability Coverage (occurrence Form CG 0001) with limits no less than one million dollars (\$1,000,000) per Occurrence and two million dollars (\$2,000,000) Aggregate for bodily injury, personal injury and property damage.
 - (a) The deductible or self-insured retention on this Commercial General Liability shall not exceed \$5,000 unless District has approved of a higher deductible or self-insured retention in writing.
 - (b) The Commercial General Liability policy shall be endorsed to include the District; its agents, officers and employees as additional insureds in the form as required by the District. An exemplar endorsement is attached (Exhibit B, Certificate of Insurance, attached hereto and incorporated herein).
 - (c) The coverage provided to the District, as an additional insured, shall be primary and any insurance or self-insurance maintained by the District shall be excess of the Service Provider's insurance and shall not contribute to it.
 - (d) The Commercial General Liability policy shall be endorsed to include a waiver of transfer of rights of recovery against the District ("Waiver of Subrogation").
- (2) Commercial Automobile Liability (Owned, Scheduled, Non-Owned, or Hired Automobiles) written at least as broad as Insurance Services Office Form Number CA 0001 with limits of no less than one million dollars (\$1,000,000) combined single limit per accident for bodily injury and property damage.

(3) Workers' Compensation, statutory limits, is required of the Service Provider and all sub-consultants (or be a qualified self-insured) under the applicable laws and in accordance with "Workers' Compensation and Insurance Act", Division IV of the Labor Code of the State of California and any Acts amendatory thereof. Employer's Liability, in an amount of not less than one million dollars (\$1,000,000) each accident, \$1,000,000 disease policy limit and \$1,000,000 disease each employee. This policy shall be endorsed to include a waiver of subrogation endorsement, where permitted by law.

 Professional Liability insurance in the amount of \$1,000,000 per claim and \$1,000,000 aggregate.

- (a) At the end of the agreement period, Consultant shall maintain, at its own expense, continued Professional Liability insurance of not less than five (5) years, in an amount no less than the amount required pursuant to this Agreement.
- (b) Alternately, if the existing Professional Liability is terminated during the above referenced five-year period, Consultant shall maintain at its own expense, "tail" coverage in the same minimum amount as set forth in this paragraph.
- (c) All coverages under this section shall be effective as of the effective date of this Agreement or provide for a retroactive date of placement that coincides with the effective date of this Agreement.
- (5) Umbrella or Excess Liability insurance with limits no less than one million dollars (\$1,000,000) per occurrence and aggregate. This policy must provide excess insurance over the same terms and conditions required above for the General Liability, Automobile Liability and Employer's Liability policies.

- b. Service Provider shall furnish District with certificates of insurance coverage for all the policies described above upon execution of this Agreement and upon renewal of any of these policies. A Certificate of Insurance in a form acceptable to the District, an exemplar Certificate of Insurance is attached as Exhibit B and made a part hereof, evidencing the existence of the necessary insurance policies and endorsements required shall be kept on file with the District. Except in the event of cancellation for non-payment of premium, in which case notice shall be 10 days, all such policies must be endorsed so that the insurer(s) must notify the District in writing at least 30 days in advance of policy cancellation. Service Provider shall also provide notice to District prior to cancellation of, or any change in, the stated coverages of insurance.
- c. The Certificate of Insurance must delineate the name of the insurance company affording coverage and the policy number(s) specifically referenced to each type of insurance, either on the face of the certificate or on an attachment thereto. If an addendum setting forth multiple insurance companies or underwriters is attached to the certificate of insurance, the addendum shall indicate the insurance carrier or underwriter who is the lead carrier and the applicable policy number for the CGL coverage.
 - d. Furnishing insurance specified herein by the District will in no way relieve or limit any responsibility or obligation imposed by the Agreement or otherwise on Service Provider or Service Provider's sub-contractors or any tier of Service Provider's sub-contractors. District shall reserve the right to obtain complete copies of any of the insurance policies required herein.
- 11. <u>ACCURACY OF SERVICES</u>. Service Provider shall be responsible for the technical accuracy of its services and documents resulting therefrom and District shall not be responsible for discovering deficiencies therein. Service Provider shall correct such deficiencies without additional compensation. Furthermore, Service Provider expressly agrees to reimburse District for any costs incurred as a result

of such deficiencies. Service Provider shall make decisions and carry out its responsibilities hereunder in a timely manner and shall bear all costs incident thereto so as not to delay the District, the project, or any other person related to the project, including the Service Provider or its agents, employees, or Sub-Service Providers.

- 12. INDEPENDENT CONTRACTOR. Service Provider and any agent or employee of Service Provider shall act in an independent capacity and not as officers or employees of District. The District assumes no liability for the Service Provider's actions and performance, nor assumes responsibility for taxes, bonds, payments or other commitments, implied or explicit by or for the Service Provider. Service Provider shall not have authority to act as an agent on behalf of the District unless specifically authorized to do so in writing. Service Provider acknowledges that it is aware that because it is an independent contractor, District is making no deductions from its fee and is not contributing to any fund on its behalf. Service Provider disclaims the right to any fee or benefits except as expressly provided for in this Agreement.
- 13. <u>ADVICE OF COUNSEL</u>. The parties agree that they are aware that they have the right to be advised by counsel with respect to the negotiations, terms and conditions of this Agreement, and that the decision of whether or not to seek the advice of counsel with respect to this Agreement is a decision which is the sole responsibility of each of the parties hereto. This Agreement shall not be construed in favor of or against either party by reason of the extent to which each party participated in the drafting of the Agreement. The formation, interpretation and performance of this Agreement shall be governed by the laws of the State of California.
- 14. **INDEPENDENT REVIEW**. Each party hereto declares and represents that in entering into this Agreement it has relied and is relying solely upon its own judgment, belief and knowledge of the nature, extent, effect and consequence relating thereto. Each party further declares and represents that this Agreement is being made without reliance upon any statement or representation not contained

herein of any other party, or any representative, agent or attorney of any other party.

- 15. **INTEGRATION AND MODIFICATION.** This Agreement contains the entire Agreement between the parties and supersedes all prior negotiations, discussion, obligations and rights of the parties in respect of each other regarding the subject matter of this Agreement. There is no other written or oral understanding between the parties. No modifications, amendment or alteration of this Agreement shall be valid unless it is in writing and signed by the parties hereto.
- 16. **OWNERSHIP OF RECORDS.** Any and all materials and documents, including without limitation drawings, specifications, computations, designs, plans, investigations and reports, prepared by Service Provider pursuant to this Agreement, shall be the property of District from the moment of their preparation and the Service Provider shall deliver such materials and documents to District at the Don L. Nay Port Administration Building (located at 3165 Pacific Highway, San Diego, California 92101) whenever requested to do so by District. However, Service Provider shall have the right to make duplicate copies of such materials and documents for its own file, or other purposes as may be expressly authorized in writing by District. Said materials and documents prepared or acquired by Service Provider pursuant to this Agreement (including any duplicate copies kept by the Service Provider) shall not be shown to any other public or private person or entity, except as authorized by District. Service Provider shall not disclose to any other public or private person or entity any information regarding the activities of District, except as expressly authorized in writing by District.
- 17. <u>TERMINATION</u>. In addition to any other rights and remedies allowed by law, the Executive Director (President/CEO) of District may terminate this Agreement at any time with or without cause by giving thirty (30) days written notice to Service Provider of such termination and specifying the effective date thereof. In that event, all finished or unfinished documents and other materials shall at the option of District be delivered by Service Provider to the Don L. Nay Port Administration Building (located at 3165 Pacific Highway, San Diego, California 92101).

Termination of this Agreement by Executive Director (President/CEO) as provided in this paragraph shall release District from any further fee or claim hereunder by Service Provider other than the fee earned for services which were performed prior to termination but not yet paid. Said fee shall be calculated and based on the schedule as provided in this Agreement.

18. **DISPUTE RESOLUTION**

- a. If a dispute arises out of or relates to this Agreement, or the alleged breach thereof, and is not settled by direct negotiation or such other procedures as may be agreed, and if such dispute is not otherwise time barred, the parties agree to first try in good faith to settle the dispute amicably by mediation administered at San Diego, California, by the American Arbitration Association, or by such other provider as the parties may mutually select, prior to initiating any litigation or arbitration. Notice of any such dispute must be filed in writing with the other party within a reasonable time after the dispute has arisen. Any resultant Agreements shall be documented and may be used as the basis for an amendment or directive as appropriate.
- b. If mediation is unsuccessful in settling all disputes that are not otherwise time barred, and if both parties agree, any still unresolved disputes may be resolved by arbitration administered at San Diego, California, by the American Arbitration Association, or by such other provider as the parties may mutually select, provided, however, that the Arbitration Award shall be non-binding and advisory only. Any resultant Agreements shall be documented and may be used as the basis for an amendment or directive as appropriate. On demand of the arbitrator or any party to this Agreement, Sub-Service Provider and all parties bound by this arbitration provision agree to join in and become parties to the arbitration proceeding.
- c. The foregoing mediation and arbitration procedures notwithstanding, all claim filing requirements of the Agreement documents, the California Government Code, and otherwise, shall remain in full force and effect

regardless of whether or not such dispute avoidance and resolution procedures have been implemented, and the time periods within which claims are to be filed or presented to the District Clerk as required by said Agreement, Government Code, and otherwise, shall not be waived, extended or tolled thereby. If a claim is not timely filed or presented, such claim shall be time barred and the above dispute avoidance and resolution procedures, whether or not implemented or then pending, shall likewise be time barred as to such claims.

19. **PAYMENT BY DISTRICT.** Payment by the District pursuant to this Agreement does not represent that the District has made a detailed examination, audit, or arithmetic verification of the documentation submitted for payment by the Service Provider, made an exhaustive inspection to check the quality or quantity of the services performed by the Service Provider, made an examination to ascertain how or for what purpose the Service Provider has used money previously paid on account by the District, or constitute a waiver of claims against the Service Provider by the District. The District may in its sole discretion withhold payments or seek reimbursement from the Service Provider for expenses, miscellaneous charges, or other liabilities or increased costs incurred or anticipated by the District which are the fault of or as result of work performed or negligent conduct by or on behalf of the Service Provider. Upon five (5) day written notice to the Service Provider, the District shall have the right to estimate the amount of expenses, miscellaneous charges, or other liabilities or increased costs and to cause the Service Provider to pay the same; and the amount due the Service Provider under this Agreement or the whole or so much of the money due or to become due to the Service Provider under this Agreement as may be considered reasonably necessary by the District shall be retained by the District until such expenses, miscellaneous charges, or other liabilities or increased costs shall have been corrected or otherwise disposed of by the Service Provider at no expense to the District. If such expenses, miscellaneous charges, or other liabilities or increased costs are not corrected or otherwise disposed of at no expense to the District prior to completion date of the Agreement, the District is authorized to pay for such expenses, miscellaneous charges, or other liabilities or increased costs from the amounts retained as outlined above or to seek reimbursement of same from the Service Provider. It is the express intent of the parties to this Agreement to protect the District from loss because of conduct by or on behalf of the Service Provider.

20. COMPLIANCE WITH PREVAILING WAGE LAWS (IF APPLICABLE)

- a. Service Provider acknowledges and agrees that it is the sole and exclusive responsibility of Service Provider to: (a) ensure that all persons and/or entities (including, but not limited to, Service Provider or Subcontractors) who provide any labor, services, equipment and/or materials (collectively, "Services") in connection with any work shall comply with the requirements of California's and any other prevailing wage laws ("PWL") to the extent such laws are applicable and (b) determine whether any Services are subject to the PWL by obtaining a determination by means that do not involve the District.
- b. <u>Certified Payrolls</u>. Service Provider acknowledges and agrees that it is the sole and exclusive responsibility of the Service Provider to insure that all certified payrolls are provided to the District. Service Provider shall submit certified payrolls electronically via the software LCPtracker.
 - (1) LCPtracker is a web-based system, accessed on the World Wide Web by a web browser. Service Provider will be given a Log-On identification and password to access the San Diego Unified Port District's reporting system upon Service Provider's request.
 - The use of LCPtracker by the Service Provider is mandatory. Access
 to LCPtracker will be provided at no cost to the Service Provider.
 - (3) In order to utilize LCPtracker, the Service Provider needs a computer and internet access. A digital camera and a scanner may be useful. For more information, go to www.lcptracker.com. To Login, go to

www.lcptracker.net and from the homepage, select LOGIN and enter the Username and Password that will be provided to you by the District upon Service Provider's request.

- (4) Use of the system will entail data entry of weekly payroll information including; employee identification, labor classification, total hours worked and hours worked on this project, wage and benefit rates paid etc. The Service Provider's payroll and accounting software might be capable of generating a 'comma delimited file' that will interface with the software.
- (5) Service Provider must require all lower-tier sub participants the mandatory requirement to use LCPtracker to provide any required labor compliance documentation. Lower-tier sub participants will be given a Log-On identification and password from the Service Provider.
- (6) Training options can be provided to the Service Provider upon request.

21. <u>SERVICE PROVIDER/CONTRACTOR REGISTRATION PROGRAM (IF</u> <u>APPLICABLE)</u>

a. In accordance with the provisions of Labor Code section 1771.1. (a) A contractor or subcontractor shall not be qualified to bid on; be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5. It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered

to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

- b. No contractor or subcontractor may be listed on a bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].
- c. No contractor or subcontractor may be awarded a contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.
- d. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.
- 22. **CONFLICT OF INTEREST.** Service Provider represents and warrants the following:
 - a. No Current or Prior Conflict of Interest. That Service Provider has no business, professional, personal, or other Interest, including, but not limited to, the representation of other clients, that would conflict in any manner or degree with the performance of its obligations under this Agreement.
 - b. Notice of Potential Conflict. If any such actual or potential conflict of interest arises under this Agreement, Service Provider shall immediately inform the District in writing of such conflict.
 - c. Termination for Conflict. If the District determines that such conflict poses a material conflict to and with the performance of Service Provider's obligations under this Agreement, then the District, in its sole and absolute discretion, may terminate the Agreement immediately upon written notice to Service Provider. Such termination of the

Agreement shall be effective upon the receipt of such notice by Service Provider.

- 23. **<u>CAPTIONS</u>**. The captions by which the paragraphs of this Agreement are identified are for convenience only and shall have no effect upon its interpretation.
- 24. <u>EXECUTIVE DIRECTOR'S SIGNATURE</u>. ATTACHMENT A SCOPE OF SERVICES

San Diego Unified Port District

1. Scope of Services

- a. Services provided may include the following:
 - (1) Collection of marine sediment and bay water, groundwater, stormwater, outfall discharges and soil; sampling fish, invertebrates and other organisms or other miscellaneous sample collection activities, as needed. Services may involve sampling during dry weather or rain events, monitoring storm drain outfalls, and/or sampling bay water and/or sediment by boat. Samples may be collected for biological, microbiological, chemical, physical, and toxicological analysis.
 - (2) Conducting marine life surveys, including but not limited to eelgrass and Caulerpa taxifolia surveys and report writing.
 - (3) Conducting special studies related to National Pollutant Discharge Elimination System (NPDES) permit regulatory compliance. Total Maximum Daily Loads (TMDLs), Investigative Orders, regulatory orders, and site assessment.
 - (4) Analytical peer reviews and assistance in regulatory document review.
 - (5) Monitoring plan and Quality Assurance Project Plan (QAPP) development, implementation and technical report writing.
 - (6) Project management and meeting attendance with or on behalf of the District as needed for applicable monitoring.
 - (7) Assistance updating and implementing the District's Jurisdictional Runoff Management Program (JRMP) programs. Work may also include analysis

of pollutant sources based on monitoring data and updating JRMP monitoring programs and integration with watershed high priority conditions.

- (8) Assistance with reporting, monitoring and technical research related to the San Diego Bay Watershed Water Quality Improvement Plan and the state-led trash amendments.
- (9) Providing staff capable of responding within one business day or less to collect samples of sediment, stormwater, bay water, fish and other marine and/or benthic organisms, hazardous waste, or other substances on District tidelands for laboratory analysis.
- (10) Providing staff available to monitor for incoming rainstorms which may generate sufficient runoff for stormwater collection. Service provider will also have staff available during operating hours (may include weekend work) to collect storm water samples at District facilities during the wet weather season (generally October - May).
- (11)Assistance with education outreach to District stakeholders related to NPDES permit compliance, TMDLs and other regulatory orders, site assessment, or special studies. Assistance may include, but not limited to, preparation of outreach materials and presentations, participation in outreach events and assistance with outreach event set-up. Education outreach activities may also include presentations of project or report findings or updates to District staff, regulators and the general public.
- (12)Assistance with regulatory permit preparation and submittals to applicable resource agencies including but not limited to Army Corps of Engineers permits and Water Quality Certifications.

b. Sample Collection and Analysis Requirements

- (1) Analytical requirements under this agreement include, but are not limited to: biological, chemical, microbiological, physical, and/or toxicological analyses of sediment, water, and hazardous waste. Service Provider must demonstrate a thorough knowledge of marine sediment analysis, soil chemistry analysis, and water quality analysis. Service Provider shall also be knowledgeable and experienced with statistically evaluating data, performing trend analysis, providing recommendations based on monitoring data, and summarizing findings for technical and general audiences.
- (2) Service Provider will provide sample collection and analytical services in accordance with all applicable federal, state, and local regulations and NPDES permits including, but not limited to the State Water Resources Control Board (SWRCB) General Construction Activities Storm Water Permit, the Regional Water Quality Control Board's (RWQCB) Municipal Storm Water Permit (Order No. R9-2013-0001), TMDLs, and other regulatory orders.
- (3) Service provider will be required to conduct marine life surveys according to the applicable regulations or established protocols including but not limited to the Caulerpa Control Protocol issued by the California Department of Fish and Game and the National Marine Fisheries Service (NMFS) and the Southern California Eelgrass Mitigation Policy issued by NMFS.
- (4) Service provider shall have demonstrated expertise and ability to present highly technical analytical information to the general public, regulators and in-house District staff.
- (5) Service Provider is responsible for furnishing all equipment and materials required to collect samples. All disposable materials furnished by the

Service Provider must be new and unused. Service Provider will provide District with sample collection containers, coolers, sample labels, sample preservative supplies, filter media and chain of custody forms as needed. Sample collection containers will include the appropriate preservative as required. Service Provider is also responsible for transporting samples to the analytical laboratories within the required holding times.

- (6) Service Provider personnel assigned to collect samples for the District must be 40-hour OSHA trained per 29 CFR 1910.120. Service Provider personnel are also required to obtain Transportation Workers Identification Cards (TWIC) for access to marine and cruise ship terminals.
- (7) All waste, including hazardous waste generated by the Service Provider and/or Sub-consultants in the course of conducting District projects shall be the Service Provider's responsibility to store, transport, and dispose of in accordance with federal, state, and local laws. Service Provider shall be responsible for proper storage and ensure that a proper transporter and disposal facility has been approved. All contractors shall comply with California and Federal OSHA regulations or any other appropriate laws.
- (8) Service Provider and its laboratories must demonstrate the ability to respond rapidly to District requirements. Service Provider must provide sample container delivery and pick up in an expedient manner. Service Provider is expected to meet required turnaround times for sample analysis and reporting. The laboratory or laboratories providing analysis of samples must be certified by the California State Department of Health Services, have a National Environmental Laboratory Accreditation (NELAC) accreditation or applicable agency, and be capable of meeting the California Surface Water Ambient Monitoring Program (SWAMP) detection limits.

(9) Service Provider or the subcontracted laboratory will be responsible for the storage of District samples, including archiving if requested, and final disposal of samples including hazardous waste disposal in accordance with applicable federal, state, and local regulations. Upon completion of the required analysis and FINAL submittal of the analytical report. Service Provider or the subcontracted laboratory is expected to hold the sample(s) for at least 60 days prior to disposal.

c. Quality Control/Quality Assurance and Reporting

- (1) Service Provider shall ensure chemical analysis quality control/quality assurance (QC/QA) procedures are followed. QC/QA assurance procedures should include documentation of analytical reproducibility, analytical detection limits, reference materials, instrument calibration, and record keeping for various tests, which are consistent with applicable Green Book, SW-846, and/or SWAMP protocols. The appropriate analysis of blanks, reagent blanks, and standard reference materials shall be performed.
- (2) All work shall be conducted in accordance with current criteria and regulations established by District and regulatory agencies. Service Provider shall ensure that all work products generated by the Service Provider or its Sub-consultants are typewritten, neat, and legible. All elements of submittal from Service Provider shall be completely and thoroughly checked by the Service Provider before submittal to the District.
- (3) Service Provider shall ensure all quality assurance/quality control procedures are met by the laboratory, including: calibration procedures and frequency, data analysis, validation, reporting, internal quality control checks, preventative maintenance, procedures to assess data precision accuracy and completeness, sample storage and tracking. All laboratory reports will be typewritten, well presented, easily understood, and

consistent in format. QA/QC results will also be included with the analytical results. All laboratory report pages will contain the name of the laboratory, sample identification number, name of the analytical test, analytical results, date the samples were analyzed, the time analysis was initiated, percent standard deviation, page number of the laboratory report, description of and results of control runs and method blank analysis, and the name of the person responsible for analysis.

- (4) The Service Provider may be required to develop a QAPP that outlines all quality assurance/quality control procedures for sampling and analytical activities consistent with California SWAMP requirements. The QAPP must be prepared prior to monitoring and submitted to the District for review and approval. A copy of the approved QAPP shall be present with the Service Provider during monitoring events and shall be strictly followed. The QAPP must be included in final report(s) submitted to the District. If sampling or analytical methods deviate from the QAPP or data is determined to contain errors, the District shall be notified immediately and a remedy shall be implemented to correct the problem or inaccuracy. If the Service Provider chooses to sub-contract analytical work or other work to an outside vendor, applicable standard operating procedures (SOPs) should be provided and included as appendices of the QAPP subject to review by the District.
- (5) Service Provider shall ensure that all project-related final laboratory reports, data, submittals, field logs and other documents are turned in to the District at the end of the project. These materials are to be submitted in both PDF and Word versions.

d. Electronic Data Submittal Standards

- (1) Service provider may be required to upload monitoring data to the California Electronic Data Exchange Program (CEDEN). Service Provider shall submit data according to CEDEN requirements.
- (2) The District's Environmental Protection Department is implementing environmental Electronic Data Deliverable (EDD) Specifications to standardize and streamline the process by which environmental data are collected, organized, compiled, stored, processed, reported, transmitted, and archived. EDD Specifications will allow the District to access summary and detailed information on a data management and geographic information systems (GIS) platform.
- (3) The use of EDD Specifications will be assigned on a project by project basis by the District. At the will of the District, EDD Specifications may be used for all projects under this contract including: the collection of project and field environmental data and measurements, laboratory analysis, and reports. When requested, EDD Specification-compliant deliverables are required for all field investigations and field sampling activities for all media. EDD Specification-compliant electronic deliverables will generally include, but will not be limited to:
 - (a) site location information,
 - (b) project information,
 - (c) locational and sample data,
 - (d) field measurements,
 - (e) physical, chemical, and biological measurements of media assessed,
 - (f) electronic submission of laboratory reports,
 - (g) electronic submission of all paper document submittals, and
 - (h) photographs
- (4) All electronic submittals shall conform to EDD Specifications and shall be submitted in a format that is consistent with software used by the District.

The EDD specification compliant electronic submittals, including but not limited to: reports, figures, appendices, data tables, spreadsheets, and database files pertaining to a project or task order shall be submitted to the District within ten business days for all tests performed unless other arrangements have been approved by the District. The District may specify additional electronic submittals in the individual request for services.


