TC offers the following response to Eagle Paving Company, Inc.'s (Eagle) bid protest.

AMERICAN ASPHALT SOUTH, INC.

Attached please find a copy of American Asphalt South, Inc. proposal which clearly shows the total bid amount submitted for line item # 6 as \$35,000.00. The difference of \$5,000.00 which brought the total subcontractor listing to \$40,000.00 was due to receiving an extra cost from Lyle Stone for an additional mobilization to perform the work in two separate mobilizations. The additional \$5,000.00 was included in Schedule A Bid Item 1 – General Construction. Which, according to Section 01 27 00 – MEASUREMENT AND PAYMENT Part 1.3.B., states "which price shall constitute full compensation for completion of all mobilization and demobilization". Therefore, there is not a clerical error in the subcontractor listing as claimed by Eagle.

STATEWIDE STRIPES, INC

Attached please find a copy of Statewide Stripe, Inc. proposal. The difference in the two items Eagle mentioned is due to two factors. The first being a rounding issue, which is insignificant, and the second being the placement of the mobilization costs. Statewide Stripes estimate contained 6 moves, I had spoken with Adam Orellana at Statewide Stripes prior to the bid opening and asked him to separate the cost of the 6 moves so I could include those costs in Schedule A Bid Item 1 – General Construction.



Which, according to Section 01 27 00 – MEASUREMENT AND PAYMENT Part 1.3.B., states "which price shall constitute full compensation for completion of all mobilization and demobilization". The 6 Moves were \$500.00 each for a total of \$3,000.00. Therefore, there is not a clerical error in the subcontractor listing as claimed by Eagle.

TC considers Eagles bid protest as frivolous, and in accordance with SECTION 4.2.3.3 of the Contract Documents "The Board of Port Commissioners will issue a decision on the protest. If the Board of Port Commissioners determines that a protest is frivolous, the party originating the Protest may be determined to be irresponsible and that party may be determined to be ineligible for future Contract awards."

Based upon this information, TC's bid is both responsible and responsive. Eagle's bid protest is without merit and should be rejected by the Port of San Diego.
