

**FIRST AMENDMENT TO
AGREEMENT FOR POLICE, FIRE AND EMERGENCY MEDICAL SERVICES**

This First Amendment to Agreement for Police, Fire and Emergency Medical Services ("**Amendment**") is made and entered into this _____ day of _____, 2021 by and between the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, hereinafter called "District," and the CITY OF CORONADO, a municipal corporation, hereinafter called "City."

RECITALS

WHEREAS, District and City previously entered into that certain Agreement between San Diego Unified Port District and City of Coronado for Police, Fire and Emergency Medical Services (the "**Original Agreement**"), which Original Agreement was filed in the Office of the District Clerk on March 12, 2013 as Document No. 59978; and

WHEREAS, District and City wish to amend the Original Agreement to extend the term thereof through June 30, 2022 in accordance with the terms of this Amendment.

AGREEMENT

NOW THEREFORE, for valuable consideration, District and City agree to amend the Original Agreement as follows:

1. **Term of Agreement.** The term of the Original Agreement is hereby extended to cover services rendered through June 30, 2022.

2. **Compensation.** For the fiscal year commencing on July 1, 2021 and ending on June 30, 2022, District shall pay City an amount not to exceed \$1,186,119.00 for City's performance of the services contained in the Scope of Services and pursuant to the terms of the Original Agreement (as amended by this Amendment).

3. **Entire Agreement.** The Original Agreement, as amended by this Amendment, represents the entire and integrated agreement between District and City with respect to the subject matter thereof and supersedes and cancels any and all previous negotiations, representations, and agreements, whether written or oral. To the extent of a conflict between the terms of the Original Agreement and the terms of this Amendment, the terms of this Amendment shall control.

4. **Amendments.** Except as expressly amended by this Amendment, all terms, covenants, and conditions of the Original Agreement shall remain in full force and effect. No further amendment or modification of the Original Agreement (as amended by

this Amendment) shall be effective unless in a writing signed by District and City.

5. **Counterparts.** This Amendment may be executed in any number of counterparts, including executed counterparts delivered via email through an electronic portable document format (including PDF), each of which shall be deemed an original, but all of which together shall constitute the same instrument.
