FY 2019 DISTRICT FUNDS INCLUDE MAJOR MAINTENANCE AND EQUIPMENT OUTLAY AND OTHER CAPITAL PROJECTS. FUNDS REQUIRED FOR FUTURE YEARS WILL BE BUDGETED IN THE APPROPRIATE FISCAL YEAR, SUBJECT TO BOARD APPROVAL UPON ADOPTION OF EACH ANNUAL BUDGET
